## Moving Steadily Forward

THE ANIMAL FOUNDATION HAS RAISED \$1,078,259 at this writing in its capital campaign for a state-of-the-art animal shelter and dog park! What a testimony to the generosity of so many people and to the value people place on helping animals. The Foundation's goal is to raise a total of \$2.2 million, so we are nearly halfway to the target.

The Foundation contracted with Animal Arts/Gates Hafen Cochrane, a Colorado architectural firm which has specialized in designing animal care facilities for 27 years. Based on what they learned through their assessment visit to Great Falls, the architects prepared a conceptual design of the new animal shelter.

Mark Hafen relates that he strove to incorporate elements of historic buildings in Great Falls to make the structure not only aesthetically pleasing but also compatible with other buildings in the community.

As the design reveals, the homeless cats and dogs in Great Falls will have an impressive place to live while they wait for people to adopt them and take them to their forever homes. The staff, volunteers and visitors will also enjoy a healthy, comfortable, pleasing environment. Although critics might contend the proposed design is too grand for animals, the new shelter will be more than a holding place for strays. It is foreseen the facility will become a community center for animal welfare activities. Along with being a safe, pleasant place for homeless animals to live, the building will provide space for adoption services, animal control services, animal training, humane society activities and community education. In short, the animal shelter will be a gathering place for people who care about animals and are interested in improving animals' lives in Great Falls.

In addition to fundraising and selecting sites for the animal shelter and dog park (see pages 2-3), trustees from the Animal Foundation are meeting with Humane Society of Cascade County director Chuck Tourillot to determine the approximate size and configuration of the new shelter. Specific questions, such as how many dog kennels will be needed or what size the communal cat colonies should be, are being addressed. Consideration is being given to a multitude of factors to best meet the needs of the animals and people who will be using the facility.

Once the size and use determinations have been made, Animal Arts will design preliminary floor plans using their expertise in animal behavior and health. The architectural firm will make recommendations regarding mechanical designs and building materials best suited for an animal care

facility. They will also provide revised cost estimates prior to the project being handed off to a local architectural firm.

The board of the Animal Foundation has one other major endeavor in the works—attending the Fur Ball on April 22 and having a great time!

## Shelter Site Chosen

GOOD NEWS! The Animal Foundation and the City of Great Falls have come together and selected the optimum location for the new animal shelter. Although a street address will not be assigned until the project progresses further, the site is immediately south of North Middle School on 25th Avenue NE between 6th and 8th Streets NE.

Ultimately, the site will encompass four acres—more than enough room to meet the requirements of a new building and to allow for future expansion if that should ever be necessary.

The site is centrally located, an important feature for the convenience of those going to the shelter and for the delivery of efficient animal control services. The attractive new building will be a great addition to the visible, high traffic area where it will be located. The site is easy to find, which is another advantage for anyone who wishes to visit



the shelter. Once the new shelter is built and people see for themselves the monumental differences between a state-of-the-art shelter and the current facility, it is the Animal Foundation's belief the number of people who visit the shelter to adopt animals will dramatically increase.

The site is within the city limits so the infrastructure is in place to the property boundary. The cost of building a new facility will not have to include substantially extending water and sewer lines or constructing roads. These improvements are very expensive and the Foundation worked hard to find an appropriate location which would not require undertaking these types of site development. Another plus for building the animal shelter at this site is the relative lack of potential conflicting interests.

A “future home of” sign marks the western edge of the property where the new shelter will be built. The Animal Foundation would like to thank **Johnson-Madison Lumber Company** for donating lumber for the sign posts and **Matthew Gressard** for installing the sign.

We encourage you to drive by the site and envision the building which will one day be there to house homeless animals and provide a center for animal welfare events and activities in Great Falls.





# Dog Park Progress *Melanie Lattin*

DOGS IN GREAT FALLS—and the people who want a protected, enjoyable place to let their dogs run free—will be happy to learn a site has been chosen for the dog park.

The dog park will be developed on an approximately three-acre site west of 9th Street North between the River's Edge Trail and the railroad tracks. The property belongs to the City of Great Falls and is undeveloped park land. The site is expansive enough for two areas for dogs: one for large dogs and another separate area for small or elderly dogs.

The dog park will be a vital addition to the special use areas in the Park and Recreation Department's inventory of parks. Just as particular parks in Great Falls are designed to be used by people who wish to golf, swim, play soccer or skateboard, the dog park will provide a place in the sun for people who wish to safely and legally allow their dogs off leash to run and play with other dogs.

People who like to walk their dogs on River's Edge Trail will be able to spice up their regular walks by unleashing their dogs to run and play with other dogs before continuing on with their walks. And, as many people who have dogs know, watching dogs play is a form of entertainment in itself.

Once the Animal Foundation has finalized a conceptual drawing of the dog park, dog-loving people in the community will be organized to spread the word about the dog park and to help raise funds to develop the park.

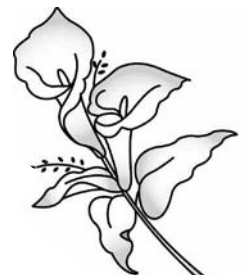

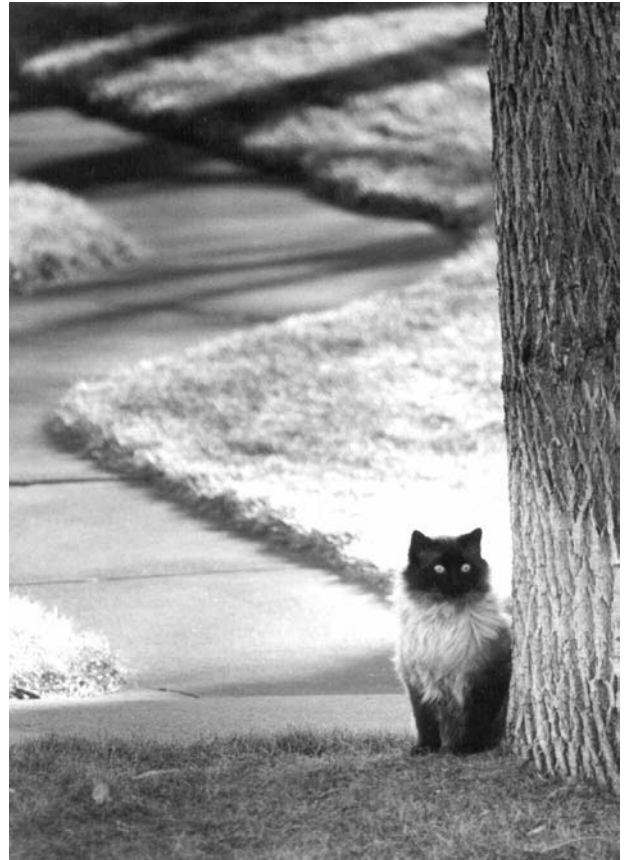
